

NEW MSCI INDEX FUTURES CONTRACTS TO BE LISTED FOR TRADING ON SEPTEMBER 13, 2021

Effective with the start of trading for trade date Monday, September 13, 2021¹, ICE Futures U.S. will begin trading new futures contracts on the following MSCI Indexes:

MSCI China NTR Index (contract symbol CHH)

MSCI USA Small Cap GTR Index (contract symbol USC)

MSCI Germany NTR Index (contract symbol GEA)

MSCI Italy NTR Index (contract symbol ITH)

Full contract specifications for the new contracts are attached to this notice. At launch five expiry months will be listed for each of the contracts: December 2021, March 2022, June 2022, Sep 2022 and Dec 2022.

Exchange and Clearing fee rates for these contracts will be identical to the fees for the existing futures contracts: \$1.20 per side for screen trades and \$1.75 per side for Block and EFRP trades. Additional information on the Exchange's MSCI Index contracts can be found here.
